#### 10. Annual Report by CEO on other major activities

The highlights of the year for Grace were as follows:

- The last summer was an incredible season for operators and the season. 16% yearly increase from 2019 was reported. Some towns reported 30% increase!
- Winter 2023 has been tough for operators but ECTT is working on initiatives for Winter 2024 including continued integration with Tourism Tasmania's OffSeason campaign
- Grace spent a lot of time initially getting to understand the challenges and opportunities that are available on the coast and ECTT now has a very solid plan in moving forward and will push for the Positive Impact Plan to come to life
- Grace has stabilised the team and now has Mel in the North, Sally in the South and Kiley taking care of the social media channels
- Continued advocacy for improved road infrastructure communication services, solutions for workers
  accommodation and the Positive Impact Plan. These are three big priorities that will take
  precedence in the coming year

- There was some big wins at the 2023 National Tourism Awards with Wukalina Walk winning Gold, Big4 St Helens Holiday Park and Tas Walking Co both winning Silver. This is a fantastic representation of the standard of operators on the Coast
- Implemented quarterly industry Awards. To date, there has been 30 Awards given out. The themes included Guest Love, Positive Impact. Accessibility & Inclusivity and Innovation (to be awarded in Nov / Dec 2023)
- Coached 8 businesses through to the TICT Tourism Awards

Grace thanked the East Coast Tasmania Tourism team and the Board, industry stakeholders and industry partners.
